4. Each exhibiting company must have badges for all their attending representatives. Additional exhibitor badges are available for purchase at the rate of € 150.00 excl. VAT for 3 days.

5. Payment is due 30 days after receipt of the invoice, and in any event paid prior to Congress. Payments that have not been received prior to congress may lead to delay in your company accessing the exhibition.

6. The congress is liable to meet the French, Dutch and European VAT regulations. In case of a change in the VAT rates, this will be charged through as well.

7. Force majeure: If due to war, strikes, industrial action short of a strike, import or export embargo, lockouts, accidents, fire, blockade, flood, natural catastrophes, pandemics and epidemics or other obstacles over which the party has no control the party shall not be held responsible for any loss or damage which may be incurred as a result of such failure.
